Install seven hundred linear feet (700') of six foot (6') high 9-gauge galvanized chain link with top and bottom rail to create 20 kennels. Install three hundred feet (300') of bottom rail on existing fence behind kennels to prevent dogs from escaping. Install a top on 3 kennels.

Qualifications:

1. Location of underground utility, irrigation, drainage, cables, pipes, etc. (furnished by customer).
2. Payment Terms: Net 15 days. Payment with credit card ADD 6%
3. No electrical grounding of fence or gates included in this price.
4. Preparation such as, but not limited to: cleaning, grading, tree or obstruction removal shall be furnished by others.
5. Not responsible for any restoration of any part of the landscape, existing or new that is disturbed during fence installation.
6. No core drilling or jack hammering included in this price. Price based on all posts in dirt & concrete footings.
7. No bonding included in this price.
8. If this price is accepted, this proposal/contract shall be considered an attachment of the sub-contract and all information within shall supersede all other documents including but not limited to the sub-contract.
9. All fencing shall be field located by the Owner's representative.
