This amendment will increase Hotel/Motel Tax Fund revenue in the amount of \$23,600 and increase the Hotel/Motel Appropriation in the amount \$23,600. This amendment will increase Jail House Store Fund revenue in the amount of \$200 and increase the Juvenile Court-Supervision Fee Appropriation in the amount \$200. This amendment will increase Jail House Store Fund revenue in the amount of \$268,000 and increase the Jail House Store Fund Appropriation in the amount of \$6,000. This amendment will increase CI Inmate Education Fund revenue in the amount of \$6,000. This amendment will increase Special Projects Fund revenue in the amount of \$33,000 and increase the Special Projects Fund Appropriations in the amount of \$33,000. This amendment will increase American Rescue Plan Fund Appropriations in the amount of \$2,779,000 and increase the American Rescue Plan Fund Appropriations in the amount of \$2,779,000. This amendment will increase the Public Safety Fund revenue by \$80,000 and increase the Public Safety Fund Appropriations in the amount of \$80,000.
